Ashoka WhiteOak Emerging Markets Trust plc (the `Company') announces that it has issued 125,000 new ordinary shares of one penny each (the `Ordinary Shares') pursuant to its block listing facility. This figure 38,589,329 may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to, their interest in the Company under the Financial Conduct Authority's Disclosure Guidance and Transparency Rules.
