These distributions were paid on January 2, 2020, April 6, 2020, July 2, 2020, October 2, 2020.

To the extent the nontaxable distribution exceeds the adjusted basis of the issuer's stock, a shareholder should recognize gain from the sale or exchange of its Iron Mountain Incorporated stock under IRC Section 301(c)(3).
