This Privacy Policy (hereinafter referred to as "Policy") concerns the conditions for collecting, storing, and using your personal data from **Dorian LPG (USA) LLC**, when you visit the website <a href="http://www.dorianlpg.com/">http://www.dorianlpg.com/</a> under the condition you are a natural person. # 1. A few words about <a href="http://www.dorianlpg.com/">http://www.dorianlpg.com/</a>

The domain <u>http://www.dorianlpg.com/</u> is the website of the DORIAN LPG Ltd and its subsidiaries and affiliates. **Dorian LPG (USA) LLC**, a Company incorporated under the laws of state of Delaware, USA, and based in Stamford, Connecticut, shall act as the Data Controller under this privacy policy (hereinafter referred to as "Company, We, Us").

The Personal Data you provide us during your visit to our website is processed by the Company, which acts as a Controller towards your Personal Data.

## 2. What is personal data?

The term "personal data", as used to this Policy, refers to a natural person's (either an individual or a professional) data such as full name, postal address, e-mail address, telephone number, etc. that can identify or be used to identify the website's visitor, hereinafter referred to as "Personal Data" or "Data".

## 3. What is the Processing of Personal Data?

Processing of Personal Data is the collection, registration, organization, structure, storage, adjustment or alteration, recovery, search for Data, use, disclosure by the transfer of Data, dissemination or any other form of disposal, association or combination, limitation, erasure or destruction to natural person's Personal Data.

## 4. What kind of Personal Data do we collect?

We may process Personal Data via our "investor inquiries" segment (e.g. name, e-mail, contact number) based on our legitimate interest to serve your inquiry, our "email alerts" segment of our website (e.g. name, email, notification preferences) based on the lawful basis of consent, and our "careers" segment of our website (e.g. name, e-mail, contact number, CV) in order to take steps at your request prior to entering into a contract. We do not collect and process special categories of Personal Data (personal data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, and the processing of genetic data, biometric data for the purpose of uniquely identifying a natural person, data concerning health or data concerning a natural person's sex life or sexual orientation) via our website. In case you forward us special categories of Personal Data, it will be deleted immediately and will not be further processed.

We do not collect any additional Personal Data about you via our website except for the Data from the cookies you have permitted to be used, according to our <u>Cookies Policy</u>.

### 5. For what purposes do we process your Data?

We collect your Data solely for the purposes of a) receiving investors' inquiries, b) your subscription to our "email alerts", c) communicating with you regarding a job opening in our Company via our "careers" contact form and d) complying with the obligations imposed from the current legislation.

### 6. Who are the recipients of your Data?

The recipients of your Data are the strictly necessary personnel of the Dorian LPG Group, who is committed to confidentiality, and its cooperating companies which process your Data as Data Processors on its behalf and based on its instructions, such as the website's service provider.

Moreover, it is possible that we share your Data with or send them to a competent public authority, if we are under a legal obligation to do so.

## 7. How do we ensure that our Data Processors respect your Data?

Our Data Processors have agreed with the Company and are contractually bound:

- to maintain confidentiality,
- not to transfer Data to third parties without our written permission,
- to undertake organizational and technical data security measures,
- to comply with the legal framework for the protection of Personal Data, especially with the General Data Protection Regulation (GDPR)

#### 8. Do we transfer your Data abroad?

As part of our global activity we might transfer your Personal Data to countries located either inside or outside of the European Economic Area. The recipients of such transfers will either

be subsidiary companies, belonging to our Group, or Data Processors, which are contractually bound with our companies. Any such transfers are made only if the appropriate conditions of GDPR are met.

#### 9. When do we erase your Data?

Your Personal Data are retained by us only for as long as it is required according to the purpose of the processing and the applicable law. In any case, your Data will not be retained for a period that exceeds 1 year for CVs and 7 years for other details collected.

### 10. Are your Data safe and secure?

We commit to safeguard your Personal Data. We have taken all the appropriate organizational and technical measures to secure and protect your Data from any form of accidental or fraudulent processing.

#### 11. What are your rights?

Regarding your Personal Data, you possess the right to:

- 1. inquire whether we process your Personal data or not, access your Personal Data that we process, and obtain a copy thereof,
- 2. correct the Personal Data you have provided us,
- 3. restrict the processing (a) when you dispute the accuracy of your Personal Data and until we verify it, (b) when you are opposed to the deletion of Personal Data but you do not wish to delete it, (c) when your Personal Data is not necessary for the purposes of the processing, but is necessary for the foundation, exercise, support of legal claims, and (d) when you object to the processing, for the time period between your submission of a request to exercise your right to object and the Company's decision on whether to satisfy or not the aforementioned request,
- 4. request the transfer of your Personal Data to another Controller,
- 5. oppose at any time the processing of your Personal Data when it is necessary for the purposes of your legitimate interests,
- 6. delete your Personal Data,
- when the processing is based on your consent, revoke the consent you have given us at any time, without prejudice to the lawfulness of the processing based on your consent, before you recall it.

You have the right to lodge a complaint before the relevant authority of your residence for issues concerning the processing of your personal data. In order to obtain more information on how to file a complaint, you can visit relevant authority's website where detailed information is available.

We will reply to your requests for free, without delay, and in any case within one (1) month after we receive your request. However, if your request is complex or you submit a large number of requests, we will notify you within one (1) month in case we need to take a two (2) months extension, within which we will respond back to you.

If your requests are obviously unfounded or excessive particularly because of their recurring nature, the Company may impose a reasonable fee, taking into account the administrative costs for providing data or performing the requested action, or refuse to respond to the request. We will provide you with the justification of any such decision.

#### 12. A few more information

We do not make automated individual decision-making including profiling.

Our website is not intended for minors under 16 years of age
